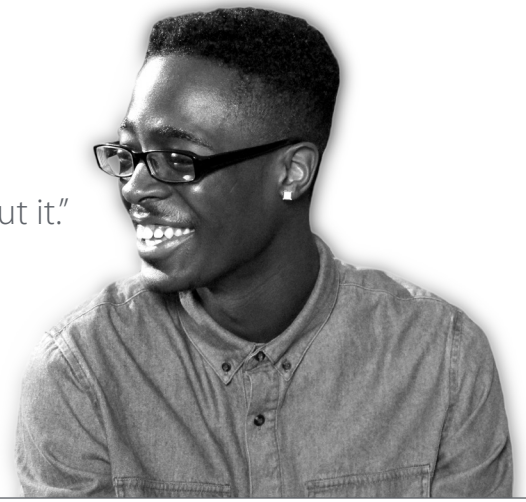

SPONSORSHIP LEVELS AND BENEFITS

All sponsorships of \$5,000 or greater are eligible for Missouri Youth Opportunity Program tax credits.

GROUP ONE SPONSORS

(\$21,800 is tax-deductible)

COURSE SPONSOR | \$20,000

(\$17,440 is tax-deductible)
