Wyman has been awarded a limited allocation of Missouri **Neighborhood Assistance Program (NAP)** tax credits to support **Wyman Leaders**, a college access and leadership development program that helps young people build confidence, strengthen life skills, and prepare for success after high school.

Why Make a NAP Gift?

A qualifying gift to Wyman may provide:

- A 50% Missouri state tax credit on your donation*
- A federal charitable income tax deduction if you itemize*
- The opportunity to redirect tax dollars to help local young people thrive
- Support for a proven leadership and educational and career success program
- A meaningful way for your business to invest in the future workforce of our region

Who Qualifies?

Businesses with Missouri tax liability and individuals with Missouri business income may be eligible to receive NAP tax credits if:

- Donor is increasing their annual gift to Wyman or donating to Wyman for the first time
- Donation amount is generally \$1,000 or more
- Donation is made via check, credit card, or stocks.

Tax credits are limited and available on a first-come, first-served basis.

Why Now?

NAP tax credits are a powerful way for eligible businesses and business-income donors to make a larger philanthropic investment while reducing Missouri tax liability. For donors who qualify, NAP can help turn a gift to Wyman into both immediate community impact and a smart charitable giving strategy.
